

# Pool Usage Information

## **The guest policy for the pool is as follows:**

To help keep capacity and seating at a comfortable level, there is a limit of 5 non-member guests per membership when coming to the pool.  
Groups of more than 5 guests must be prearranged with Maria, our Event Coordinator, who will be able to review the schedule for availability.  
This also helps with staffing for the day.

The guest fee is \$5 per individual for the pool area.  
(The pool area includes anywhere inside the pool fence.)

## **Pool Hours:**

Tuesday – Sunday, 10am – 8pm  
The pool will close at 7:15pm if there are no swimmers.

Monday – Noon – 8pm  
The pool will close at 7:15pm if there are no swimmers.  
NOTE – THE POOL WILL CLOSE AT 4PM FOR MONDAY EVENTS.  
PLEASE SEE THE CLUB CALENDAR FOR SPECIAL MONDAY HOURS.

Please note the following exceptions for Monday holidays for the pool hours:  
Monday, May 27, 2024 10AM Opening | Tuesday, May 28, 2024 Noon – 8PM  
Wednesday, July 3<sup>rd</sup>, 2024 10AM – 5PM (for Pool Party) | Thursday, July 4, 2023 10AM – 8PM  
Monday, September 2, 2024, 10AM Opening

## **To help you, your family, and guests be informed, please review the following FCCC Pool rules:**

ALL members must sign-in upon arrival.  
Please register using your first & last name, your member number and, if you have brought guests, the number of guests with you.  
Members will be charged a fee for their guests on their monthly statement.

Members are responsible for their guests and to ensure that they are abiding by the rules.  
Guests include anyone who is not included in your current membership.

Parents, guardians, and/or sitters are responsible for their children in the wading pool.

We will have qualified lifeguards on duty as much as possible during regular pool hours until school begins in August. During inclement weather, guards may be sent home. If there are no guards on duty, a sign will be posted outside the gated area. Please remember, lifeguards are not babysitters for member's children and are not responsible for children outside of the pool enclosure.

### **General Rules & Regulations:**

Lifeguards shall be responsible for the enforcement of all rules and regulations. They retain the right to take appropriate action that will guarantee the safety and rights of everyone in the pool area.

**Behavior rules:** Members and guests shall behave and swim with respect and safety of others using the pool:

- a. No running on deck or patio area.
- b. No horseplay allowed at any time.
- c. No pushing or throwing anyone into the pool.
- d. No one is allowed on the island inside the lazy river at any time. There is no jumping allowed into the pool surrounding the lazy river at any time.
- e. No persistent yelling or screaming shall be allowed. Fun should be had by all but please be respectful of golfers on the nearby greens and teeing areas.
- f. No sitting or hanging on ropes when they are in use.

**General rules:** The following rules apply in addition to those outlined above:

- a. Food WILL be allowed in the pool area this season on a trial basis. Food inside the pool area should only be consumed at the tables and lounge chair areas only. NO food is to be consumed sitting on the pool edge or inside the pool. Members are asked to place disposable items in one of the trash containers before leaving the pool and/or patio areas.
- b. No glass or breakable objects shall be allowed in the pool or patio area.
- c. Water games are allowed if other swimmers are not inconvenienced.
- d. Toys, rafts and other large floatation devices are not allowed when the pool is crowded.
- e. No children under seven (7) years of age shall be allowed in the pool enclosure unless accompanied by an adult or have displayed swim competency for lifeguards.
- f. **Smoking and/or vaping is not allowed** in the pool area and respect should be provided to members eating on the patio.

#### **All food and drink must be purchased through FCCC.**

No outside food, drink or coolers are allowed.

Servers will be scheduled to work around the pool area to take and bring your orders at most times until mid-August when school begins.

You can also make your purchases at the outside window next to the water station.

Food orders will be brought to the patio or pool tables.

Swimwear is not allowed inside the clubhouse except in the locker room area.

Swimwear is not allowed on the course, driving range, or practice green.

#### **For patio rental, small parties, or any groups of more than 5 guests:**
